# 4. MINUTES OF MEETING HELD ON 12th FEBRUARY 2025

An update on the critical road structures was requested and Gerald confirmed that he is producing a policy for inclusion in the Plan. A paper detailing all roads in and out of Hartley has already been circulated to the Group. Chris has asked the Parish Council to undertake a vehicle count.

#### 5. PROGRESS ON OUTSTANDING WORKS

# **Updating the Plan**

A further update of the plan has been circulated by Gary together with a note of the outstanding matters following the meeting with Derek Stebbing on 4<sup>th</sup> March 2025. In future paper copies will be made available at the Parish office. All members were asked to review the updated plan and advise Gary of any required amendments asap.

# **Community Assets**

It was agreed that shops and the dental practice should remain within this category. Gerald agreed to photograph each of the assets for inclusion in the plan.

#### **Local Green Spaces**

Gerald had circulated a paper providing information on each site and Tracy agreed to merge the information into the NPPF audit tool. A photograph and map will be required for each site. All members were asked to review Gerald's paper by Wednesday 19<sup>th</sup> March. Gerald will then send final version to Tracy to complete the NPPF audit tool.

It was agreed to add the Memorial Green and Hoselands Green to the list of Local Green Spaces. The former is also included as a proposed Conservation Area but it was noted that it would take many years for this to be arranged.

Each Local Green Space will need to be referred to its owner in order to gain permission to include in the Neighbourhood Plan. Such responses should then be included in the plan or the consultation statement.

# **Businesses and Employment**

Gary has updated this section in the Plan. It was agreed that the names of businesses should be included.

#### **Consultation Statement**

Stephanie has amended the paper and forwarded to Gary who will work with Chris to develop it further as a standalone report. Mark is producing the Basic Condition Report.

# **Adoption of Documents**

A number of documents included in the Neighbourhood Plan need to be adopted by the Parish Council (eg Design Code, Housing Needs). It was agreed that this should take place at the same time as the Neighbourhood Plan is adopted.

It was agreed that Chris, Mark, David and Tracy would meet week commencing 14<sup>th</sup> April to review the current version of the Plan.
