4. MINUTES OF MEETING HELD ON 4th JUNE 2025

Matters Arising

- a) Chris to contact SDC for the form to obtain the biodiversity map.
- b) In relation to the land in Hartley which SDC has indicated is in their ownership and could be made available for sale, David confirmed that SDC has contacted the Parish Office and this matter was discussed at the last Parish Council meeting. The Council's view is that none of the land should be auctioned but retained as open space. The one concern is the plot which forms part of the Woodland recreation ground, located at the opposite end to the playground. The Council has disputed the ownership of this land with SDC and is awaiting a response. It was agreed that the land should be included within the Local Green Space map for the Woodlands recreation ground.

Resolved that the minutes of the meeting dated 4th June 2025 be approved and adopted.
